# **ABOUT**

The <u>Black Health Primer</u> is a multi-module, online, and self-paced course on Black health and anti-Black racism in the Canadian healthcare system. It was created in response to gaps in education and training on Black health and anti-Black racism in medicine and public health in Canada. The course is suitable for all medical and health profession learners, faculty, educators, professionals, and practitioners (including administrative and other staff).

# **DEVELOPMENT**

Community and expert consultations supported the development of the Black Health Primer. This includes a Scientific Planning Committee composed of medical and health professionals, practitioners, educators, and learners with expertise in Black health, anti-Black racism, and critical race theory.

Through education, the Black Health Primer uses critical race theory to improve the health of Black people and communities by:



Advancing knowledge in and promoting dialogue about anti-Black racism and its impact on health



Offering solutions to address the health inequities experienced by Black people in Canada at the individual and institutional levels



Identifying how anti-Black racism presents within the health system, social and structural determinants, and affects the health of Black communities in Canada
